Gift Aid helps us do more!

Basic Rate Tax

You can make your contributions worth 28% more, at no extra cost to you, simply by making a Gift Aid declaration.

Gift Aid allows us to claim an extra 28% on top of your donation from the Inland Revenue. This means that for every £1 you donate, Elizabeth FitzRoy Support can claim an extra 28p direct from the Inland Revenue.

Higher Rate Tax

If you pay tax at the higher rate, there is an even bigger incentive for you to Gift Aid your donation! For example, on a gift of £100, we can reclaim £28 – *and you can reclaim up to £23* - by declaring the donation on your tax return form.
